REPORT ON THE V4 LAW STUDENT SUMMIT ORGANISED BY THE MATHIAS CORVINUS COLLEGIUM

The place of the event was the Hotel Conference – which is the Centre of the Mathias Corvinus Collegium in Győr between the 14th July and 17th July in 2022. Those law students who had decided to participate on the first V4 Law Student Summit had the opportunity to attend many and many up to par lectures and interactive group works. It must be highlighted that the organizers were well prepared in terms of cultural programmes. Győr is one of the most beautiful cities in Hungary. Participants had the opportunity to see the most characteristic sights of the town as the Cathedral Basilica of the Assumption of Our Lady, Town Hall and Vienna Gate Square etc.

Last but not least Dr. Roman Oleksik honoured participants with his presence as the representative of Kinstellar as well. The moderator of the discussion was Dr. Ákos Mernyei, who is a Ministerial Commissioner and assistant lecturer at the University of Public Service. The discussion was held in a nice atmosphere, very interesting topics were raised and discussed.
